## **POSITION SUMMARY**

An active member of Dallas Theater Center (DTC)'s Production Department, the First Hand is responsible for pattern finishing, cutting, and the construction of all costumes. The First Hand reports directly to the Lead Draper, and participates in effectively supporting production builds, ensuring that high artistic standards are met at all times.

This is an hourly, non-exempt position. This position includes a full benefits package: medical, dental and vision insurance, DTC-paid life insurance, voluntary life insurance and 403b programs, complimentary tickets and paid-time off. Some nights and weekends may be required throughout the season.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES**

- Consult with Lead Draper regarding the necessary construction of costumes and carry out the construction as necessary.
- Provide assignments and instructions to Stitchers and other costume shop personnel regarding garment construction, alterations, and notes. Answer questions and consult Lead Draper as necessary.
- Create pattern finishings as directed by the Lead Draper.
- Fabric cutting with high precision and attention to detail.
- Assist in the selection of costume build materials and calculation of yardages.
- Participate in the construction process including cutting, sewing, and alteration of built, purchased, or rental costumes.
- Primary note taker in all costume fittings with attention to detail regarding clarity and neatness.
- Tagging costumes with relevant work notes, organizing costumes racks, and maintaining neat fitting spaces during, between, and post fittings.
- Lead certain fittings as directed by the Lead Draper.
- Assist in measuring actors.
- Advise Lead Draper of any issues arising out of the build process and offer solutions if applicable.
- Aid in the completion and delivery of rehearsal costumes as needed.
- Pull costumes for notes, establish priorities, organize notes, and track note completion during technical rehearsals work sessions.
- Maintain designated work spaces in a clean, usable, and safe condition.
- Ensure completion of costumes in accordance with deadline requirements.
- Communicate with the Lead Draper regarding equipment condition.
- Assist in the restock and organization of costume storage.
- Assist in the organization, restock, inventory, and maintenance of costume shop resources.
- Assist the Wardrobe Supervisor and crew in the repair and maintenance of items in use in current production if beyond the capabilities of the crew.
- Assist with inventory, preparation, and packing of rental packages that originate at DTC or are received by DTC.
- Attend and participate in full company, departmental, and production meetings; in addition to technical rehearsals and previews for all productions as called.
- Read and respond to company email in a reasonable, timely manner.
- Perform work in a manner that is timely, safe, and consistent with DTC's Mission, Vision and Values
- Be an active participant in DTC's work towards equity, diversity and inclusion and becoming an anti-racist organization by:
  - o Participating in all DTC-wide EDI trainings, workshops or experiences
  - o Participating in all EDI learnings or experiences cultivated within the Production and/or Costume Department
- Maintain safe working conditions in keeping with DTC health and safety guidelines.

## ABOUT DALLAS THEATER CENTER

One of the leading regional theaters in the country and the 2017 Regional Theatre Tony Award® Recipient, Dallas Theater Center (DTC) performs to an audience of more than 100,000 North Texas residents annually. Founded in 1959, DTC is now a resident company of the AT&T Performing Arts Center and presents its Mainstage season at the Dee and Charles Wyly Theatre, and at its original home, the Kalita Humphreys Theater. DTC is one of only two theaters in Texas that is a member of the League of Resident Theatres, the largest and most prestigious non-profit professional theater association in the country. DTC produces a six-play subscription series of classics, musicals and new plays and an annual production of *A Christmas Carol*; education programs, including the Award-winning Project Discovery and a significant partnership with Southern Methodist University's
